INGREDIENTS

Calcium Carbonate, Salt, Calcium Phosphate, Vegetable Oil with Tertiary Butyl Hydroquinone (a preservative), Molasses Products, Sodium Selenite, Magnesium Oxide, Vitamin A Acetate, Vitamin D-3 Supplement, Iron Oxide, Vitamin E Supplement, Copper Sulfate, Selenium Yeast, Zinc Oxide, Zinc Sulfate, Manganous Oxide, Manganese Sulfate, Ferrous Sulfate, Cobalt Carbonate, Ethylenediamine Dihydriodide, Calcium Iodate.

FEEDING DIRECTIONS: Co-op Balancer Cattle Mineral-BOV is designed to be mixed with grains, grain by-products or other feedstuffs. Mix 50 lb of Co-op Balancer Cattle Mineral-BOV with 1,950 lb of appropriate feedstuffs to create 2,000 lb of fortified feed. Feed the resulting mix continuously at the rate of 6.66 to 24.00 lb per head per day to provide 100 to 360 mg of Lasalocid per head per day along with good-quality pasture or other long-stemmed forage and clean, fresh water.

WARNING: A withdrawal period has not been established for this product in pre-ruminating cattle.

Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid for use in unapproved species has not been established. Do not allow horses or other equines access to feeds containing Lasalocid as ingestion may be fatal. Mix thoroughly with grain and/or roughage prior to feeding. Feeding undiluted or mixing errors may result in an excess Lasalocid concentration that could be fatal to cattle and sheep. This product is designed solely as a mixing mineral and is not suitable as a mineral supplement to cattle on pasture. Do not feed to sheep or other copper-sensitive animals.
